CHURCH ON A MISSION

Café 225 – opened in 2011; third space for having a warm welcome mat and on ramp for Christian community. Lots of different activities happened there and it closed in 2022. We did vote to demolish it, but it was a lot pricier than we thought, so we have paused any action. We would like to look at new missions for this space. Possible new ministries: Friday Night Social Ministry, Alpha. Light and Light Counseling, SRM partnership.

- Facilities Repeal the motion to scrape 225 Weber and ask Session to authorize a task force to draw up plans to restore Café 225 and renovate the third floor for use as a Counseling Center.

HEALTHY SESSION GOVERNANCE

Bill Enns – Knot Navigators

Dave introduced Bill Enns from Knot Navigators to discuss what it means to be healthy elders and what roles the elders play at a church our size.

Healthy Elders: The spiritual life of Elders – How does and elder stay spiritually healthy in the role? Their task is 1 Peter 5:1-4 - Elders are shepherds – this is their critical role. How does a Session lead a church alongside a Pastor and Staff? How does an individual elder play an appropriate part of governance, accountability, and responsibility alongside a Staff in a Lare church? Elders' primary role is pastoral not administrative. They should make sure people feel loved, encouraged and like they belong, no single pastor can do that. As you gather in meeting is to discern the will of the Lord, you have a discussion so that it isn't just a decision but a discernment.



Sessions have authority but no one elder does – we are a corporate body not a individuated group, an elder can be commissioned by the session for a specific responsibility but only session can speak with an authority.

What do you do when there is conflict?

- Actively Support
- Passively Submit
- · Peacefully Withdrawal

Elders cannot contradict what session has approved. None of us act alone as individuals, we all must be part of the discussion. You must commission your Ministry Teams, the more authority you give to the Team the more effective your ministry is going to be.

Session overseas and holds Lead Pastor and Executive Pastor accountable according to the church's mission and overall goals, but it does not give orders to staff. If directives are given then it has to come through senior leadership. Elders can get to know staff and care for them, but may not function as the staff members supervisor.

When thinking about the session meeting, half of the meeting should be discerning the mission, clarifying the mission and conforming to the vision. If something doesn't directly relate to the vision, it doesn't get done. Review the vision every month; you don't need to make changes to it all the time but can be tweaked if something is not right, but this usually does not happen regularly.

The time with Bill Enns ended in discussion in table groups and then together as a whole body.
